## C. 2024 – President's Update

UNM Peds Grand Rounds – will begin October run through December – 3 CHD topics – please share with your own medical community. A mass email went out on 9/10/24 for SAVE THE DATES – along with email to over 10 medical organizations in the State.

House Bill 9/2014: request to amend HB 9 (CCHD Newborn Screen) – add an echo cardiogram if a parent of a newborn answers YES to even one of the AAP Heart Policy Questions. Rep Thomson (Chairman), Rep Ortiz y Pino (Chairman), with Rep Hochman-Vigil leading the request to amend the bill. Hole in the Heart is to present our nonprofit and request to amend HB 9 on Tuesday, October 22 at 9am in Rio Rancho (Place TBD) to the Legislative Health & Human Services Committee. NOTES: **Kelsey & Dr. Avila**, along with **Bob & Sandra Fahrlender**, will present to LHHS Committee. Meet in early October to work on a presentation.
